DECLARATION OF TAMMY MALLEY-NASLUND

I, Tammy Malley-Naslund, hereby declare as follows:

1. I am over the age of 18 years. I am a Litigation Paralegal at Amazon.com LLC (“Amazon”). Based on my position at Amazon, I am familiar with Amazon’s email system and have experience with sending mass email messages to Amazon customers. I have personal knowledge of the facts contained herein, and, if called as a witness, I could and would competently testify to those facts.

2. On May 9th, 2018, I caused an email to be sent out on behalf of, and in the name of, Amazon to email addresses associated with Amazon customers with U.S. accounts that Amazon’s records indicate were residents of California or Texas and who purchased a HP LaserJet Pro P1102w or HP LaserJet Pro 200 Color MFP M276nw printer from Amazon’s website between April 1, 2014 and the present.

3. The subject of the email message was “Notice Regarding Class Action Settlement.” The body of the email message was in the following form:

Amazon is sending you this email because our records indicate that you may be a resident of California or Texas who purchased a Hewlett Packard printer between April 1, 2014 and the present. **If so, you might be entitled to payment from a settlement.**

In March 2018, a federal court in California approved the settlement of a class action lawsuit involving class members that purchased an HP LaserJet Pro P1102w or HP LaserJet Pro 200 Color MFP M276nw printer. **Class members may be eligible to receive \$20 per qualifying printer. You must submit a valid claim to receive a payment.** Claims must be submitted by August 7, 2018.

Amazon is sending this email on behalf of the parties to the lawsuit, and as required by the court. Because we are not involved in the lawsuit, however, we cannot assist you directly. 
